

Book Formatting Services

- **\$2.50** per page of a 6x9 inch book from the FINAL manuscript that has been completely edited by a professional editor and completely ready to publish. I understand that once you order the proof of your book, you may still find spelling and/or grammatical errors that were not caught by your editor or yourself.

If there just a few corrections to be made, or a needed correction in formatting only (such as a paragraph needs indent or a word italicized, underlined, bold, font change, etc., I'll fix those free of charge.

***If the edits surmount to several pages of spelling corrections, re-writes, paragraph changes, re-orders of text, etc, I charge an additional \$5.00 per each page to be corrected.***

- **\$80.00** format PDF of Interior and upload to Amazon (CreateSpace) server for publishing. I may have to upload a couple of times if Createspace catches an abnormalities that I need to fix. (I will do this free of charge) You will get emails alerting you that your book is being reviewed by CreateSpace. Ignore those. I will let you know when its time for you to order your proof. (see further notes below)
- **\$300.00** Design and PDF format Front and Back Cover and upload to Amazon(CreateSpace) server for publishing.
- **\$60.00** to upload your e-book to KDP.Amazon (Kindle)

**NOTE:** You will need to go to [www.createspace.com](http://www.createspace.com) (Amazon's book publishing platform) and create an account. You can do this at any time. They will want your bank info, social security number, etc for royalty payments. Yes, they 1099 you at the end of the year!

Once you create your account with [www.createspace.com](http://www.createspace.com), I will need your log-in information to start the upload and online proofing process with Amazon. Once I upload your interior and covers, I will direct you to order your first proof so we can look for any formatting or printing errors. No matter how many eyes see something, a mistake or formatting error doesn't get caught until it's in book form. This is just the nature of the beast. I tell clients to have a few people read the book proof before we ultimately submit it for sale. Proofs for a 150 page book will typically cost about \$6.50 (this includes shipping and tax).

Once your book is for sale to the public, you can order mass quantities and the price per book goes down considerably. For instance a 150 page book x 30 will be 3.30 per book (including shipping and tax)

Once your book is listed on Amazon, I will place it for sale on all distribution channels so that it shows up for sale on other online book sites as well. However, I can tell you without a doubt MOST people buy books on Amazon.

The person who does my e-book formatting is Steve Hutchins. He does a GREAT JOB and charged me \$135.00 for all e-reader formats. [stevhutch@loose-cannon.com](mailto:stevhutch@loose-cannon.com) He will format your books and send you the e-reader files. You can then send them to me and I can upload them for you on all of the needed platforms. You can ask him to format just for Kindle and the price may be lower (not sure).

Just as an FYI, I've NEVER sold a book through Nook (Barnes and Noble) even though I have my books listed there both in print and e-reader.

## HARD BACK BOOKS

Hardback books are great to give as gifts or to display on your book signing table. However, they are very pricey and not cost effective. If you would like to have a copy of your book as a hardback, go to [LuLu.com](http://LuLu.com) and set up an account. Give me the log-in info and I will upload your book to this platform and create the hardback cover. I charge **\$50.00** for this service.
